Working with AutoCAD® Architecture 2010 Software and Section 508

Section 508 of the U.S. Rehabilitation Act requires that federal agencies' electronic and information technology is accessible to people with disabilities. The Center for Information Technology Accommodation (CITA) in the U.S. General Services Administration's Office of Government-wide Policy has been charged with the task of educating federal employees and building the infrastructure necessary to support Section 508 implementation.

With this white paper, Autodesk offers background information to explain the accessibility features of AutoCAD[®] Architecture 2010 software in the context of Section 508 standards. This was done with the intent of enabling agencies to be compliant with Section 508 regulations.

The document contains subsets of the Electronic and Information Technology Accessibility Standards as published in 36 CFR Part 1194 and provides an analysis of AutoCAD Architecture 2010 in the context of these standards.

The first table provides a summary view of the Section 508 standards. The subsequent tables provide more detailed views of each subsection.

There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, "for example, equivalent facilitation." The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

This document is not intended to be a certification of compliance. This template is based on version 1.2 (5/6/2004) supplied by the U.S. government.
