

# Working with AutoCAD 2006 and Section 508

Section 508 requires that federal agencies' electronic and information technology is accessible to people with disabilities. The Center for Information Technology Accommodation (CITA), in the U.S. General Services Administration's Office of Government-wide Policy, has been charged with the task of educating federal employees and building the infrastructure necessary to support Section 508 implementation.

With this white paper, Autodesk offers background information to help our customers understand the accessibility features of Autodesk's AutoCAD® 2006 software, in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations.

The document contains subsets of the Electronic and Information Technology Accessibility Standards as published in 36 CFR Part 1194 and provides an analysis of AutoCAD as compared to these standards.

For the purposes of this paper, "AutoCAD" refers to AutoCAD 2006 and all Autodesk® industry products that are based upon the AutoCAD 2006 platform, including AutoCAD LT® 2006.

The first table of the Template provides a summary view of the section 508 Standards. The subsequent tables provide more detailed views of each subsection.

There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, "e.g., equivalent facilitation." The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

This document is not intended to be a certification of compliance. This template is based upon version 1.2 (5/6/2004) supplied by the U.S. Gov't.

(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. (c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. (i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element. (j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	AutoCAD and AutoCAD LT provide a wide variety of color selections. The user has the ability to customize the application window. Users can also use pre-defined named colors as described by PANTONE, RAL, and DIC.	
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	AutoCAD and AutoCAD LT do not use flashing or blinking text.	
(l) When electronic forms are used, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues.	Microsoft Active Accessibility applications like the Narrator can be used to access particulars of the components of a form/dialog box.
