The purpose of the **Voluntary Product Accessibility Template**, or **VPAT™**, is to assist Federal contracting officials and other buyers in making preliminary assessments regarding the availability of commercial “Electronic and Information Technology” products and services with features that support accessibility. Autodesk provides this information to help our customers understand the accessibility features of this Autodesk product in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations. This document is not intended to be a certification of compliance. It is assumed and recommended that offerers will provide additional contact information to facilitate more detailed inquiries.

The first table of the Template provides a summary view of the Section 508 Standards. The subsequent tables provide more detailed views of each subsection. There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, e.g., “equivalent facilitation.” The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

Supports with exceptions	<p>Keyboard input is provided for most commands.</p> <p>Also, a command line enables the user to type in commands directly and specify other input.</p> <p>Supports keytips for toolset tabs and most widgets in toolsets. When panels are minimized, keytips don't work. The Panel minimize function does not have a keyboard access method.</p> <p>Provides inconsistent information about user interface elements via the Apple Universal Access Application. The focus shall be programmatically exposed so that Assistive Technology can track focus and focus changes.	Supports	Focus is programmatically exposed through command line scripting and C++ programming interface.

(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	Supports	Color-coding is not used as the only means of conveying information. The user can enter a color index or in certain cases an RGB value. Users can also use predefined named colors as described by PANTONE®, RAL, and DIC® color systems.
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	Supports	AutoCAD 2011 for Mac provides a wide variety of color selections. The user has the ability to customize the application window. Users can also use predefined named colors as described by PANTONE, RAL, and DIC.
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	Supports	AutoCAD 2011 for Mac does not use flashing or blinking text.
(l) When electronic forms are used, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues.	Supports	Apple Universal Access application can be used to access particulars of the components of a form or dialog box.
