

AUTODESK LOGO LICENSE AGREEMENT

THIS IS A LEGAL AGREEMENT BETWEEN AUTODESK, INC., A DELAWARE CORPORATION, WITH A PRINCIPAL PLACE OF BUSINESS AT 111 MCINNIS PARKWAY, SAN RAFAEL, CALIFORNIA 94903 ("AUTODESK"), AND YOU (EITHER YOU PERSONALLY, OR THE COMPANY OR OTHER LEGAL ENTITY ON WHOSE BEHALF YOU ARE ACCEPTING THIS AGREEMENT). BY USING ANY AUTODESK LOGOS (INCLUDING, WITHOUT LIMITATION, AUTODESK PARTNER LOGOS, AUTODESK PRODUCT COMPATIBLE LOGOS, AUTODESK INVENTOR CERTIFIED LOGOS, COLLECTIVELY "LOGOS") PROVIDED ON THIS AUTODESK DEVELOPER NETWORK EXTRANET SITE AT <http://adn.autodesk.com> ("SITE"), EITHER BY DOWNLOADING OR ACQUIRING THEM BY ANY OTHER MEANS, YOU AGREE TO THE TERMS AND CONDITIONS OF THIS AUTODESK LOGO LICENSE AGREEMENT ("LICENSE") AND YOUR AUTODESK DEVELOPER NETWORK PROGRAM AGREEMENT ("ADN AGREEMENT"), WHICH IS INCORPORATED BY REFERENCE HEREIN. IN THE EVENT OF A CONFLICT BETWEEN THIS LICENSE AND THE ADN AGREEMENT, THE TERMS OF THIS LICENSE SHALL PREVAIL.

BY SELECTING THE "I ACCEPT" BUTTON BELOW THIS LICENSE OR BY DOWNLOADING OR USING THE AUTODESK LOGOS PROVIDED HERE, YOU AGREE TO BE LEGALLY BOUND BY THIS LICENSE.

All capitalized terms not defined herein shall have their respective meanings as set forth in the ADN Agreement.

1. License

1. During the term of this Agreement, Autodesk permits You to indicate to the public that You are an authorized developer or partner of Autodesk and to advertise authorized Developer Works as compatible with Autodesk Software. Subject to your compliance with the terms and conditions of this License and the ADN Agreement, Autodesk hereby grants to You a nonexclusive, nontransferable, nonsublicensable, limited license, to use the Logo solely in conjunction with your Developer Work(s) and/or Your marketing materials only in the manner set forth in the Site for each type of Logo. You may only use the Logo that corresponds to Your current Autodesk authorization.

2. Autodesk owns all right, interest and title in and to the Logos. You acknowledge that nothing in this License shall give You any right, title, or interest in the Logo, other than the express rights granted herein. Any and all right that may be acquired and all goodwill that may arise by Your use of the Logos under this License will inure to the sole benefit of Autodesk.

2. Restrictions

1. **License Restrictions.** The above license grant is conditioned upon the following restrictions:
 - (i) The name of your Developer Work is independent from, does not resemble, and does not include an Autodesk trademark or service mark as part of its name. Your Developer Work cannot be confusing to or construed by the general public as being an Autodesk product or service.
 - (ii) Your product or service may not be advertised, designed, packaged, or delivered in a way that imitates Autodesk product packaging, advertisements, designs, styles, or color choices.
 - (iii) If any of the Logos are to be used in conjunction with another logo or trademark on or in relation to the Developer Works, then the Autodesk Trademarks shall be presented equally legibly, equally prominently, but nevertheless separated from the other logo or trademark so that each appears to be a logo or trademark in its own right, distinct from the other.

3. Term and Termination

1. This License will continue in force until it is terminated as follows:
 1. If either party provides written notice of termination to the other, such termination to take effect thirty (30) days after the date of notice. For purposes of this Agreement, "notice" as used herein includes electronic notice, including email notice and/or posting a termination notice on the Site.
 2. Autodesk may immediately terminate this License, at Autodesk's sole discretion, if You fail to comply with any of the terms or conditions of this License or Your ADN Agreement or if the criteria described on the Site for obtaining the Logo license have not been fully met.
 3. Upon termination of the ADN Agreement and/or your ADN membership, this License will be automatically terminated.
2. Upon termination of this License, You must immediately cease and desist Your use of the Logo. Upon request of Autodesk, You will destroy all of Your packaging or marketing materials that incorporate the Logos or copies thereof then in Your possession, and certify to Autodesk Your compliance with this provision.

Unless otherwise specifically addressed in this License, all Logos will be deemed "ADN Materials" as defined in the ADN Agreement and all terms relating to ADN Materials (including, without limitation, Indemnity, Disclaimer of Warranties, Limitation of Liability) shall apply the same to the Logos.
