

# Working with AutoCAD Map3D 2010 and Section 508

Section 508 requires that federal agencies' electronic and information technology is accessible to people with disabilities. The Center for Information Technology Accommodation (CITA), in the U.S. General Services Administration's Office of Government-wide Policy, has been charged with the task of educating federal employees and building the infrastructure necessary to support Section 508 implementation.

With this white paper, Autodesk offers background information to help our customers understand the accessibility features of Autodesk's AutoCAD® Map 3D 2010 software, in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations.

The document contains subsets of the Electronic and Information Technology Accessibility Standards as published in 36 CFR Part 1194 and provides an analysis of AutoCAD as compared to these standards.

The first table of the Template provides a summary view of the section 508 Standards. The subsequent tables provide more detailed views of each subsection.

There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, "e.g., equivalent facilitation." The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

This document is not intended to be a certification of compliance. This template is based upon version 1.2 (5/6/2004) supplied by the U.S. Government.

<b>Section 1194.21 Software Applications and Operating Systems</b>		
<b>Criteria</b>	<b>Supporting Features</b>	<b>Remarks and explanations</b>
(a) When software is designed to run on a system that has a keyboard, product functions shall be executable from a keyboard where the function itself or the result of performing a function can be discerned textually.	Supported with exceptions	Certain functionality, such as Display Manager, Map Explorer, and Workflow Designer do not support keyboard control.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.	Supported with exceptions	AutoCAD Map3D software does not disrupt or disable the accessibility features of the Windows OS or other products, However, certain features such as the Ribbon User Interface, the Workflow Designer Toolbar, and the command line window do not support high-contrast.
(c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. The focus shall be programmatically exposed so that Assistive Technology can track focus and focus changes.	Supported with exceptions	Control and focus indication are not supported in some UI elements.
(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. When an image represents a program element, the information conveyed by the image must also be available in text.	Supported with exceptions	AutoCAD Map3D software provides information to the user via the Microsoft® Active Accessibility Application, However, some of the Workflow Designer dialog buttons do not have tool tips.
(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning assigned to those images shall be consistent throughout an application's performance.	Supported	Bitmap images and actions associated with them are consistent and universally accepted images for specific functions are used.

(f) Textual information shall be provided through operating system functions for displaying text. The minimum information that shall be made available is text content, text input caret location, and text attributes.	Supported with exceptions	Some actions initiated from Task Manager are not displayed in the text window (F2). Thus this information is not available in the log file, either.
(g) Applications shall not override user selected contrast and color selections and other individual display attributes.	Supported	
(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.	Supported	Animated displays are included within the product's Help System. The same information is documented with text and images.
(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	Supported	Supported, However, map stylization may rely on color to distinguish regions on a map.
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	Supported with exceptions	AutoCAD Map3D software provides a wide variety of color selections. The user has the ability to customize the application window. Users can also use pre-defined named colors as described by PANTONE, RAL, and DIC, However, some palettes do not support the adjustment of color and contrast settings.
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	Supported	AutoCAD Map3D software does not use flashing or blinking text.
(l) When electronic forms are used, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues.	Supported	Microsoft Active Accessibility applications like the Narrator can be used to access particulars of the components of a form/dialog box.

<b>Criteria</b>	<b>Supporting Features</b>	<b>Remarks and explanations</b>
(a) At least one mode of operation and information retrieval that does not require user vision shall be provided, or support for Assistive Technology used by people who are blind or visually impaired shall be provided.	Supported with exceptions	AutoCAD Map3D software supports Assistive Technology. However, certain functions such as the Task Pane and Workflow Designer do not support keyboard navigation.
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	Supported with exceptions	A few of the Workflow Designer buttons lack textual representations, such as labels or tool tips.
(c) At least one mode of operation and information retrieval that does not require user hearing shall be provided, or support for Assistive Technology used by people who are deaf or hard of hearing shall be provided.	Supported	AutoCAD Map3D software does not require user hearing in order to operate the software.
(d) Where audio information is important for the use of a product, at least one mode of operation and information retrieval shall be provided in an enhanced auditory fashion, or support for assistive hearing devices shall be provided.	Supported	AutoCAD Map3D software does not require user hearing in order to operate the software.
(e) At least one mode of operation and information retrieval that does not require user speech shall be provided, or support for Assistive Technology used by people with disabilities shall be provided.	Supported	AutoCAD Map3D software does not require user speech in order to operate the software.
(f) At least one mode of operation and information retrieval that does not require fine motor control or simultaneous actions and that is operable with limited reach and strength shall be provided.	Supported with exceptions	Drafting in AutoCAD Map3D software generally requires fine motor skills. Also, some functions lack keyboard controls.

(a) Product support documentation provided to end-users shall be made available in alternate formats upon request, at no additional charge.	Supported	Support documentation is available within the product, as hardcopy, or as Adobe PDF.
(b) End-users shall have access to a description of the accessibility and compatibility features of products in alternate formats or alternate methods upon request, at no additional charge.	Supported	This document is posted on our website at <a href="http://www.autodesk.com">http://www.autodesk.com</a>  Search for " Government Accessibility "
(c) Support services for products shall accommodate the communication needs of end-users with disabilities.	Supported	Support services options are available via webpage, e-mail, fax, or phone. Direct, in-person support is also available through resellers.
