Autodesk provides this information to help our customers understand the accessibility features of this Autodesk product in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations. This document is not intended to be a certification of compliance. It is assumed and recommended that offerers will provide additional contact information to facilitate more detailed inquiries.
